19	WHEREAS, The Reno Municipal Court (RMC), has ceased issuing bench warrants for
20	violations punishable as a civil infraction pursuant to sections 24, to [36,] 36.7, inclusive;
21	WHEREAS, RMC is canceling all outstanding bench warrants issued before January 1,
22	2023 for violations of law that will be punishable as a civil infraction pursuant to sections 24, to
23	[36] 36.7 of AB 116;
24	WHEREAS, AB 116 limits RMC's ability to address these outstanding cases;
25	By this Order, The warrant team is hereby authorized to purge and close any outstanding
26	failure to appear warrants and the underlining charges associated with said warrant, issued prior to
27	01/01/2023 that fall within the following parameters:
28	• Contains only violations that will be punishable as a civil infraction,

1	• Do NOT involve a traffic accident for cases initiated in 2022 (cases initiated and at
2	warrant prior to 2022 may be closed and purged pursuant to this Order), and
3	• Contains violations that will be punishable as a civil infraction and any of the
4	following misdemeanor charges, with no accident involved:
5	$\circ$ Operating Vehicle with Expired Registration,
6	$\circ~$ Resident Operating Vehicle without NV Vehicle Registration, and
7	<ul> <li>Driving without a Driver's License.</li> </ul>
8	This Administrative Order will remain in effect until further notice.
