

The justice court system is centuries old. According to former Nevada Supreme Court Justice Cliff Young, the Act of 1361, written in England, officially created the office of justice of the peace. In Young's "From Kings' Courts to the Justice Courts: A Notable Judicial Odyssey," he describes the king's appointment of these judges to keep the peace, arrest and detain offenders, and decide if they had committed a felony or a trespass.

Five hundred years later in 1861, the act of Congress that created the Territory of Nevada also created the office of justice of peace. The Territorial Legislature provided that the justices of the peace be appointed by the county commissioners, and that the Common Law would be the rule of decision in the courts, as long as that law was not repugnant to the U.S. Constitution and the Nevada Territory. The legislature also voted to limit the justice court jurisdiction to small dollar amounts and to exclude real property disputes.

Today, these limited jurisdiction courts are courts of record, either through recording the proceedings or hiring a court reporter. The justices of peace determine probable cause and the sufficiency of the evidence to bind a defendant over to district court, set bail and appoint counsel for indigent defendants, and they are the first protector of people from unfair governmental treatment. In addition, justices of the peace preside over misdemeanor cases, traffic matters, evictions and disputes up to \$10,000. NRS 4.010 through 4.420.

Currently, the Clark and Washoe County justices of peace must be licensed Nevada lawyers, admitted to practice, and qualified electors. In the rural counties, however, the only qualifications for candidates are that they must be high school graduates, or have an equivalent education, and be qualified electors. Additionally, a candidate for justice of the peace must never have been removed from judicial office. The county voters elect their justices of the peace, in non-partisan elections, to a six-year term, or the county commission may appoint a qualified person to fill a vacancy for an unexpired term.

When preparing to represent a client in a justice court, an attorney should determine if the justice court has adopted local rules, and if so, review them before appearing in court. Lawyers should also check for a court website with relevant information. In the larger jurisdictions, the court may have its own website; other courts may be listed only on their county's website, as a department of government; and in the smallest of jurisdictions, the court may not have a website

at all. The information on these websites is often incomplete. Before venturing out to a rural justice court, call the court to confirm the dates and times the court is open.

In researching this article, I discovered that information on all the townships has not yet been compiled in one place. The information readily available on each court is published below. For easy reference, I grouped the justice courts under their respective district courts. The Second and Eighth Judicial District each have their own listings, while the rural courts are grouped together under their judicial districts.


