**ENTERTAINMENT LAW SECTION  
MINUTES  
June 4, 2015 MEETING**

1. **MEETING HELD:** Pursuant to duly given notice, a meeting of the Entertainment Law Section (the “Section”) was held on June 4, 2015 (the “Meeting”), at the law offices of Alverson, Taylor Mortensen & Sanders, located at 7401 W. Charleston Blvd., Las Vegas, NV, 89110.
2. **ATTENDANCE:** The following Section members attended the meeting either in person or via teleconference: Anat Levy; Matt Pruitt; David S. Kahn; Russell Christian; Howard Seigel; Jennifer Sanchez; and Tracy Gallegos.
3. **MINUTES OF April 2, 2015, MEETING:** The Minutes of the April 2, 2015, meeting were unanimously approved and ratified.
4. **POTENTIAL EVENT - LEGAL CLINIC FOR THE ARTS:** The group discussed holding a legal clinic for the arts community whereby the entertainment lawyers, perhaps in conjunction with law students from UNLV Law School, would provide legal guidance to members of the arts community in exchange for a small donation or for free. The sessions were discussed to last between 15 to 20 minutes each, and there was discussion about requiring an intake form to be first filled out by the person seeking the legal guidance. We discussed insurance and other issues related to this. Anat Levy, Jennifer Sanchez and Matt Pruitt will look into this further and will report back. The likely date of the clinic would be in September or October.
5. **POTENTIAL EVENT - VIDEO GAME LUNCHEON CLE:** The format would be similar to our recent successful luncheon CLE with speaker John Mason. The likely date would be November before Thanksgiving.
6. **JOHN MASON CLE** – This was a successful program, held at the State Bar’s new offices. It was well attended by approximately 15 people, including musician David White. The food from Rachel’s Kitchen was good. The State Bar has not yet identified whether the seminar was profitable.
7. **ANNUAL MEETING** – Last year’s annual meeting was 7/11/14. The State Bar considers our Section to have been formed in January, so the consensus is to have the next annual meeting later this year, in approximately October, though no formal date was set.
8. **OUTREACH TO OUT OF STATE ATTORNEYS** – To be discussed more at the next meeting. Entertainment lawyers and organizations from other states would be contacted.


9. **MEMBERSHIP** – The Section has approximately 35 members at present, which is an increase from last year.

10. **NEXT MEETING:** The Section’s next meeting was not formally set, but it will take place, at the Alverson firm, likely on Thursday, August 6, 2015.

11. **FINANCES:** We believe we have approximately \$1200.

With no further business to discuss, the meeting was ADJOURNED.
