INSTRUCTIONS FOR USE OF PERSONAL COMPUTERS-REMOTE ADMINISTRATION

The State Bar of Nevada is providing for the remote administration of the February 2022 Bar Examination ("Bar Exam") on computer, which will consist of seven (7) essays and two (2) performance tests. We have contracted with ILG Technologies®, a company that has developed ILG Exam360®, a program that enables an applicant to take the Bar Exam remotely on computers.

ILG Exam360® can be used on virtually any modern computer (i.e. purchased within the last 3 - 4 years). The minimum system requirements can be found on the [ILG Exam360® website for the State Bar of Nevada](https://nevada.ilgexam360.com) (<https://nevada.ilgexam360.com>). If you wish to take the Bar Exam remotely on your personal computer, you will need to complete all of the MANDATORY steps listed in the ILG Exam360® registration e-mail. Registration must be completed between 8:30 a.m. (PT) on Tuesday, January 18, 2022 and 11:59 p.m. (PT) on Friday, February 18, 2022. If you fail to complete all the required steps by the deadline and submit your Agreement to the conditions for remote administration, you will not be allowed to take the Bar Exam in February 2022.

You will receive an e-mail with instructions on **Tuesday, January 18, 2022**. If you encounter any technical issues with the software, DO NOT contact the Admissions Department. You can submit a technical support ticket from the ILG Exam360® website, from your ILG Exam360® user homepage, from within the ILG Exam360® software or call 833-ILG-SUPP (833-454-7877). **DO NOT WAIT UNTIL THE LAST MINUTE TO DO THIS**, as you may encounter problems with your computer which cannot be rectified before the commencement of the exam. Technical support during the Bar Exam will not be provided. **If you do not install ILG Exam360® on your computer and complete all of the required registration steps by 11:59 p.m. (PT) on Friday, February 18, 2022, you will not be allowed to take the February 2022 Bar Exam through a remote administration. In this event, your only option will be to take the exam in person at the Las Vegas office of the State Bar of Nevada, but only if space is available due to social distancing restrictions that may be in place, as determined by the Admissions Director in his sole discretion. If adequate space is not available to allow you to handwrite the exam in person, you will be permitted to defer taking the exam until the July 2022 bar exam.**

The option of taking the Bar Exam remotely via computer is offered to you as a convenience and privilege, not as a right. This means you are solely responsible for the condition of your computer. You will be required to have a stable internet source and permit video and audio surveillance throughout the Bar Exam. You understand and accept that if your computer or internet connection fails to work for any reason whatsoever (including, without limitation, power outages or other technical difficulty that cannot be corrected) you will not be able to continue with the Bar Exam. **It is your responsibility to make sure your equipment is in good working order and that you are computer literate.** In any event, the State Bar of Nevada bears no responsibility for the failure of any hardware or software program or consequential damages resulting from the use of a computer to take the Bar Exam.

Be aware that if you choose to use a computer to take the Bar Exam, you will **NOT** be able to see a printed copy of your exam answers. All essay and PT answers must be reviewed on screen before the conclusion of each exam session.

It is not possible to take secure exams through a virtual operating system such as Microsoft's Virtual Machine, Parallels or VMware, VMware Fusion or any other virtual operating system environment.

NOTE: You must have the capability of providing a video and audio feed that will provide a full head and torso view of you during all active testing sessions, including the sign-in periods. Any disruption of the internet connection or video/audio feed will result in the termination of your February 2022 Bar Exam and your exam will not be graded. If it is determined that the cause of the disruption was a verified system failure (not caused by you), you will be permitted to take the July 2022 Bar Exam without any additional cost.

acknowledge, understand, and agree to abide by the following:

1. I have chosen to take the February 2022 Bar Exam on computer by remote administration;
2. I must submit this signed registration form no later than **Friday, January 14, 2022 at 11:59 p.m. PST**;
3. I acknowledge there is risk involved with using a computer and accessing the testing program through my private internet source, including, but not limited to, equipment failure, software problems and electrical problems;
4. I must have the capability of providing an audio and video feed of me during the exam, which cannot be blocked or interrupted for any reason during the exam.
5. I assume all aforesaid risks associated with the use of my computer, internet and audio/video stream;
6. I will not be able to continue with the February 2022 Bar Exam in the event of any computer and/or electric problems that disconnects me from the testing program or interferes with the video/audio feed;
7. I will comply with all the rules and regulations set forth by both the State Bar of Nevada and ILG Technologies®, including timely uploading my answers;
8. I will hold the State Bar of Nevada harmless in the event of any computer and/or electrical problems;
9. I will not access any other computer or electronic device, including, without limitation, tablets, cell phones, or watches that connect to the internet, nor will I communicate in any manner whatsoever with any other individual, either in person or remotely, during a live testing session.
10. If I do not perform the mandatory registration steps by **Friday, February 18, 2022 at 11:59 p.m. PST**, I will not be allowed to take the bar exam through a remote administration. I will be required to handwrite the exam at the offices of the State Bar of Nevada in Las Vegas, Nevada, provided there is sufficient space available due to social distancing requirements, as determined in the sole discretion of the Admissions Director. If space is not available, I will be permitted to take the July 2022 bar exam without paying any penalty. Under no circumstances will my fees be refunded.
11. If the ILG Exam360® technicians find my computer skills to be inadequate, I will be required to handwrite the February 2022 Bar Exam;
12. Computer fees will not be refunded or held in abeyance for any reason;
