#### **PRESIDENT'S REPORT**

State Bar President, Julie Cavanaugh-Bill opened the BOG meeting by providing an overview of recent meetings and the 2024 Bar Conference, at which recipients of the 2024 State Bar Membership Awards were to be honored, including:

### **REPORTS/ACTION**

### Financial Report

Finance Director Marc Mersol provided a financial report for the bar through April 30, 2024. He discussed the year-to-date overall net revenue for the general fund, which was \$79,122. This amount is \$211,579 more than anticipated. Revenues for the general fund were over projections by \$151,353, and operating expenses (not including depreciation) were under-projected by \$46,078. The net revenue for all activities was \$308,140. It was moved, seconded and carried to accept the April 30, 2024, Financial Report.

### **Budget Committee Report**

The Budget Committee provided recommendations regarding a balanced budget. The Board requirement of a balanced budget in five years necessitates a plan to start increasing several revenues and reducing certain expenses over the next few years. The Committee recommended revising the balanced budget requirement putting forth an action plan for revenue increases and expense reductions beginning with the 2025 budget and that a balanced budget requirement be effective only after using \$3,000,000 of the Administrative Designated Funds, this timeframe is currently estimated to be 2031. It was moved, seconded and carried to accept the Budget Committee recommendations.

### Bar Exam Grader Fees

The Board of Bar Examiners (BBX) hires as many qualified graders as necessary to assist the BBX in the grading of the essay examinations. Graders are paid in accordance with a schedule proposed by the chair and approved by the Board of Governors.

The current compensation for bar exam graders is \$5/essay. The amount of time exam grading requires is influenced by several factors including number of exams, number of graders, and grader efficiency.,

It was moved, seconded and carried to approve BBX's recommendation to increase the bar exam grader fee to \$10/essay effective July 2024 with a 2024 budget impact of \$11,000.

## Fastcase Renewal

At its March 2024 meeting, the Board discussed whether it would continue to offer a legal research tool to all Nevada attorneys at no cost to them. The Board agreed a research tool would be valuable and directed staff to return with a recommendation. Staff evaluated platforms and recommended Fastcase (dba vLex).

Along with a robust legal research platform, including access to all 50 states and access to Nevada briefs, pleadings, motions, and orders, Fastcase provides strong legal research options and Al integration tools. It was moved, seconded and carried to approve a three-year agreement with Fastcase effective March 25, 2025.

## Office of Bar Counsel Report

Bar Counsel Daniel Hooge presented discipline statistics covering intake, investigations, and hearings.

The OBC's goal is to prosecute 80 percent of disciplinary hearings within eight months. After a screening panel approves a formal hearing, Bar Counsel files a complaint, and the case moves into the prosecution/pending hearing stage.

- The number of pending hearings as of June 1, 2024, is up more than 50 percent since January.
- The OBC presses for a hearing within eight months whenever possible. It has three cases pending over eight months. The delays in these three cases have been out of the OBC's control in large part.
- These cases represent 11 percent of the total hearing cases. So, the OBC is within its goal.

Hooge reported on the status of and issues around the discipline matter *State Bar of Nevada vs. Sarah K. Hawkins*. This matter has garnered significant interest from the criminal defense bar.

### Member Benefits Renewal

The Board reviewed the renewal of Member Benefits. This business partner provides health, dental, vision and additional insurance products as well as disability coverage. They offer health insurance plans for individuals and families as well as group health insurance for employers. It was moved, seconded and carried to approve the renewal of Member Benefits for a one-year term.

### Website Vendor

In 2022, the State Bar of Nevada's website vendor experienced staffing reductions, and as a result, subcontracted hosting, and maintenance responsibility to a new vendor. State Bar staff strongly recommended

moving the hosting and maintenance of the nvbar.org and nevadabarfoundation.org sites to a new vendor to resolve the existing issues and improve customer service. It was moved, seconded and carried to approve the KMJ Web Design contract at an estimated rate of \$16,000 per year with a 2024 budget impact of \$6,912.

#### New Section

The Board reviewed the application for a new section – Tribal Law. The stated mission of the section is to enhance the role and skills of lawyers engaged in the practice of Indian Law through study, collection, development, and dissemination of materials on subjects of interest to the Indian Law practitioners; to assist in the formation, administration, and implementation of programs, forums, and other activities for the education of members of the State Bar of Nevada in matters pertaining to Indian laws and regulations; and to recognize and discuss means of improving the practice of law in the field of Indian Law. It was moved, seconded and carried to approve the creation of the new section.

- Leverage the legal profession to educate the public on the reasons for, and the importance of, democracy and the rule of law

Most comments indicated the concern that the OBC overreached in this prosecution, seeking to prosecute a matter to resolve an unclear statute and major concerns with how this matter was managed from grievance through hearing. President Cavanaugh-Bill indicated that the Board would receive written comments in this matter through July 15, 2024.
