ADMINISTRATIVE ORDER # 20-12


WHEREAS, LVJC Administrative Order #18-04 enumerates various guidelines by which an arrested person may be released on recognizance; and

WHEREAS, due to a clerical error, various defendants posted bail, or had bail posted on their behalf, in lieu of being released on recognizance; and

WHEREAS, the Court finds that the interests of justice mandate that these bail amounts must be refunded; therefore,

IT IS HEREBY ORDERED that, for all cases listed in "Attachment A," the posted bail amounts shall be refunded as soon as possible, and the related cases shall be updated accordingly to reflect that each affected defendant is released on his or her own recognizance.
