

The 120-day 80<sup>th</sup> legislative session begins on February 4, 2019. At the time of this article's completion, 966 bill draft requests (more commonly known as BDRs in legislative parlance), have been submitted to the Legislative Counsel's office for drafting. Pursuant to NRS 218D.150, after the session convenes, each Assembly member will have one additional BDR and each senator will have two additional BDRs. These additional legislator BDRs must be submitted on or before the eighth calendar day of the legislative session (February 11).

# 2019 LEGISLATIVE PREVIEW

## Prefiled Bills

Nevada law requires that legislators prefile (or be required to withdraw) some of their BDRs prior to the start of the legislative session. (NRS 218D.150(2)) Prefiling is a process allowing for the printing of a bill prior to the beginning of the legislative session. Incumbent Assembly members must prefile at least four of the bill drafts they were allowed to request prior to the legislative session, or withdraw an equal number of BDRs.

Incumbent Senate members must prefile at least eight of the bill drafts they were allowed to request prior to the legislative session, or withdraw an equal number of BDRs. Newly-elected Assembly members must prefile two of the requests they were allotted prior to the legislative session, and each newly-elected senator must prefile four of their requests allotted to them prior to the legislative session (or withdraw an equal number of BDRs, respectively). In addition, the governor and the constitutional officers (NRS 218D.175), the Supreme Court (NRS 218D.190), local governments (NRS 218D.205) and local government associations (NRS 218D.210) are also allotted a number of BDRs. With the exception of bills necessary to implement the budget, these bills are also required to be prefiled. As a result of these requirements, many bills have already been prefiled, as noted by an Assembly Bill (AB) or Senate Bill (SB) number included on the BDRs listed in this article. The prefiling requirements were enacted in the 2015 legislative session; they ensure a much more rapid and busy pace at the beginning of the legislative session than was seen in sessions prior to 2015.

Pursuant to NRS 218D.150(5), committee chairs or designees could also request a limited number of bill drafts prior to the general election last year. One of the first actions to be taken by the Legislature will be the adoption of the Joint Rules of the Assembly and Senate, which traditionally provide that, in addition to the BDRs already submitted, an allotment of additional BDRs (60 were allowed during the last legislative session) will be allocated to each house for division among their members and standing committees. A standing committee may only request the drafting of a bill or resolution, or introduce a bill or resolution that is within the jurisdiction of the standing committee.

Legislative leadership also has an allotment of BDRs. The majority leader of the Senate and the speaker of the Assembly may have requested 15 legislative measures each prior to the 2018 general election. (NRS 218D.155) The minority leaders of the Assembly and the Senate may have requested 10 legislative measures each prior to the 2018 general election. (NRS 218D.155) The chair of the Legislative Commission and the chair of the

# 2019 Bill Draft Requests

Interim Finance Committee are both allowed 10 BDRs approved by their committees prior to the legislative session. (NRS 218D.160) Traditionally, pursuant to the Joint Standing Rules for the Senate and Assembly, adopted by the Legislature at the beginning of each legislative session, the majority leader of the Senate and the speaker of the Assembly during the legislative session may each submit to the Legislative Counsel, on his or her own behalf or on the behalf of another legislator or a standing committee of the Senate or Assembly, additional emergency requests for the drafting of a bill or resolution (last session this limit was capped at 10 such additional requests). Similarly, the minority leader of the Senate and the minority leader of the Assembly were each authorized to submit no more than three additional emergency requests for the drafting of a bill or resolution during the legislative session.

The following is a list of those BDRs, divided by general subject, that will likely be of interest to the general membership of the bar. The BDRs list sets forth the general subject of each BDR and the requester's name. The subject matter is often very vague. For example, there are bill draft requests relating to criminal law and criminal procedures that are vaguely and broadly described using the words "revises provisions relating to crimes," "revises provisions regarding criminal law," "makes various changes related to criminal law and criminal procedure," and "revises provisions relating to criminal procedure." For more details regarding the specific contents of such BDRs, the public may contact the requester of the bill, or wait to see if the bill draft is prefiled or introduced as a bill

during the legislative session and then read its content. To track a BDR, please see the item below detailing the legislature's personalized legislative tracking system.

A number preceding the dash in the BDR description has a specific meaning; for example 14-127 designates that Title 14 of the Nevada Revised Statutes (Procedure in Criminal Cases) has been identified by the Legislative Counsel's Office as encompassing the main subject of the bill draft. The number following the dash is simply the number assigned to the BDR in accordance with the order in which it was added to the BDR list. The letter C appearing before a bill draft number indicates that the BDR is for a joint resolution amending the Nevada Constitution.

Some bill drafts were requested by legislators who are no longer serving in the Legislature. In such cases, the original requestor may authorize a legislator who will be serving during the legislative session to become the primary sponsor of the legislative measure (individually or as a chair of a committee). If the serving legislator agrees to become the primary sponsor, that legislative measure is then counted as a request of the serving legislator or of the serving legislator's committee. (NRS 218D.130) As noted above, some BDRs have already been prefiled as legislative bills. In such instances, the house of introduction (AB for Assembly Bill or SB for Senate Bill) and bill number for the measures follows the BDR number. ## Personalized Legislative Tracking

Once you have identified BDRs that may be of interest to your practice, you can track your legislation free of charge, using the Nevada Electronic Legislative Information System (NELIS) on the legislative website at: <https://www.leg.state.nv.us/App/NELIS/REL/80th2019>.

A personalized bill tracking device is also available at: <https://www.leg.state.nv.us/App/NELIS/REL/80th2019/Plt>. While the same information is available on the legislative website, the personalized legislative tracking device automatically tracks bills. Use of the device is free of charge for a maximum of 10 BDRs or bills, but a fee is imposed if tracking more than 10 BDRs or bills.
