

The 120-day, 81st session of the Nevada Legislature began on February 1, 2021. At the time of writing of this article, 875 bill draft requests, more commonly known as BDRs in legislative parlance, had been submitted to the Legislative Counsel's office for drafting.

Legislator's Bill Draft Requests

Pursuant to NRS 218D.150, incumbent members of the Assembly could have submitted up to nine bill draft requests and incumbent members of the Senate could have submitted up to 18 bill draft requests on or before December 10, 2020. Newly elected members of the Assembly were able to submit up to five bill draft requests, and newly elected members of the Senate were able to submit up to 10 bill draft requests. After the session convenes, each Assembly member will have one additional bill draft requests. These additional legislator bill draft requests must be submitted on or before the eighth calendar day of the legislative session (February 8).

Prefiled Bills

Nevada law requires that legislators prefile (or be required to withdraw) some of their bill draft requests prior to the start of the legislative session. (NRS 218D.150(2)) Prefiling is a process allowing for the printing of the bill prior to the legislative session beginning. Incumbent Assembly members must prefile at least four of the bill drafts they were allowed to request prior to the legislative session, or withdraw an equal number of BDRs. Incumbent Senate members must prefile at least eight of the bill drafts they were allowed to request prior to the legislative session, or withdraw an equal number of BDRs. Newly elected Assembly members must prefile two of the requests they were allotted prior to the legislative session, and each newly elected Senator must prefile four of their requests allotted to them prior to the legislative session (or withdraw an equal number of BDRs, respectively). In addition, the governor and constitutional officers (NRS 218D.175), the Supreme Court (NRS 218D. 190), local governments (NRS 218D.205), and city and county associations (NRS 218D.210) are also allotted a number of bill draft requests. These bills (with the exception of bills requested by the governor to implement the budget or relating to collective bargaining) are also required to be prefiled. As a result of these prefiling requirements, many bills have already been prefiled as noted by an Assembly Bill (AB) or Senate Bill (SB) number included next to the bill draft request number listed in this article. The prefiling requirements were enacted in the 2015 legislative session, and ensure a much quicker and busier pace at the beginning of the legislative session than sessions past.

Committee Bill Draft Requests

Pursuant to NRS 218D.150(5), committee chairs or designees could also request a limited number of bill drafts prior to the general election last year. One of the first actions to be taken by the Legislature will be the adoption of the Joint Rules of the Assembly and Senate, which traditionally provide that in addition to the bill draft requests already submitted, an allotment of additional bill draft requests (60 were allowed during the last legislative session) will be allocated to each house for division among their members and standing committees. A standing committee may only request the drafting of a bill or resolution, or introduce a bill or resolution that is within the jurisdiction of the standing committee.

Legislative Leadership Bill Draft Requests

Legislative leadership also has an allotment of bill draft requests. The majority leader of the Senate and the speaker of the Assembly may each have requested 15 legislative measures prior to the 2020 general election. (NRS 218D.155) The minority leaders of the Assembly and Senate may each have requested 10 legislative measures prior to the 2020 general election. (NRS 218D.155) The chair of the Legislative Commission and the chair of the Interim Finance Committee are both allowed 10 bill draft requests approved by their committees prior to the legislative session. (NRS 218D.160) Traditionally, pursuant to the Joint Rules for the Senate and Assembly adopted by the Legislature at the beginning of each legislative session, the majority leader of the Senate and the speaker of the Assembly during the legislative session may each submit to the legislative counsel, on his or her own behalf or on the behalf of another legislator or a standing committee of the Senate or Assembly, additional emergency requests for the drafting of a bill or resolution – last session this limit was capped at 10 such additional requests. Similarly, the minority leader of the Senate and the minority leader of the Assembly were each authorized to submit during the legislative session, not more than three additional emergency requests for the drafting of a bill or resolution.

Bill Drafts Requested by Legislators No Longer Serving

Some bill drafts were requested by legislators who are no longer serving in the Legislature. In such cases, the original requestor may authorize a legislator who will be serving during the legislative session to become the primary sponsor of the legislative measure (individually or as a chair of a committee). If the serving legislator agrees to become the primary sponsor, that legislative measure is then counted as a request of the serving legislator or of the serving legislator's committee. (NRS 218D.130)

Personalized Legislative Tracking

Once you have identified BDRs that may be of interest to your practice, you can track your legislation using the Nevada Electronic Legislative Information System (NELIS) on the legislative website, without charge at:

While the same information is available on the legislative website, the personalized legislative tracking device automatically tracks bills. A charge is imposed for tracking more than 10 BDRs or bills on the personalized bill tracking device.

Terminology in the Bill Draft Requests List

A number preceding the dash in the BDR description, for example 14-374, designates that Title 14 of the Nevada Revised Statutes (Procedure in Criminal Cases) has been identified by the Legislative Counsel's Office as encompassing the main subject of the bill draft request. The number following the dash is simply the number assigned to the BDR, in accordance with the order it was added to the BDR list. The letter "C" appearing before a bill draft number denotes the bill draft request is for a joint resolution amending the Nevada Constitution. "AJR" or "SJR" denotes that the BDR when introduced will be in the form of an Assembly or Senate Joint Resolution.

As noted above, some BDRs have already been prefiled as legislative bills. In that instance, the house of introduction ("AB" for Assembly Bill or "SB" for Senate Bill) and bill number for the measure follows the BDR number. In such cases, the prefiled bill is now available on line for your immediate review at: https:// www.leg.state.nv.us/App/NELIS/REL/81st2021/Bills/List The list of bill draft requests sets forth the general subject of each bill draft request and the requester's name. The subject matter is often very vague. For example, there are bill draft requests relating to criminal law and criminal procedures that are vaguely and broadly described as "revises provisions relating to crimes," "revises provisions regarding criminal law," 'makes various changes related to criminal law and criminal procedure" and "revises provisions relating to criminal justice." To learn more Sessio details regarding the specific of the Nevada contents of such a bill draft request before it is prefiled or introduced as an Assembly or Senate bill, an

attorney or any other member of the public may contact the requester of the bill. To track a BDR electronically and to be notified when it is prefiled or introduced as a bill, see the paragraph detailing the legislature's personalized legislative tracking system.


