#### How Do I Update My Information on the Bar Website?

Many attorneys only log into their state bar member portal account when it is time to renew their license. (Save the date: renewal is due by January 1 every year!) However, there are several reasons to revisit your account more frequently; the address is members. nvbar.org.

One of the most frequently used tools on the bar's website is the "Find a Colleague" online directory. By logging into your state bar account, you can update your email and mailing addresses, phone numbers, and more.

By default, your username is your email address; however, you have the option to change it at any time. Once logged in, click "Update My Username/ Password." If you've changed firms, you can still use your previous email address as your username. Once logged in, you may update it using the same link listed above.

#### How Do I Change My Member Status?

If you've recently experienced a career shift, and want to change your license status from active to inactive, or vice versa; change your name; submit resignation forms; or want to record other important changes with the state bar, there's a comprehensive library of forms available at: <a href="https://nvbar.org/for-page-44">https://nvbar.org/for-page-44</a>

How Do I Show Others That I'm a Bar Member?

Some entities require formal confirmation of bar membership – no problem! Nevada bar members can order a Certificate of Good Standing through the online portal (members.nvbar.org). Statements of Disciplinary History are also available.

Did you know the bar also offers digital bar cards? You can access it from your state bar account within the "My Account" section, under "Attorney eCard." Attorneys can use the card to get into the Clark County Detention Center and some courts. It can be used in lieu of a physical bar card. TIP: Download a copy of the image onto your mobile device for fast access!

#### **How Do I Find and Earn More CLE?**

How Do I Get Access to CLE Seminars?

Live events, including the Annual Bar Conference, also provide the ability to network with other attorneys and attend fun social events as part of a package. Virtual seminars allow you to take CLE courses from the convenience of your desk on the hottest topics, while the library of pre-recorded CLE seminars offers you the ability to find educational programs specific to your individual needs – some of them are free! Another easy way to

earn CLE credit is to look for articles for CLE credit published right here in *Nevada Lawyer* several times a year.

What Are Other Ways to Earn CLE?

Become a TIP mentor! Mentors who participate in the Transitioning Into Practice program are eligible to receive six CLE credits in Nevada for each cycle they participate; the credits earned for each cycle include four general, one ethics and one substance abuse.

Volunteer to Take a Pro Bono

Case! Nevada attorneys can earn one CLE credit for every three hours of uncompensated pro bono service. You can earn up to four CLE credits each year by taking pro bono cases or participating in an Ask-A-Lawyer or Lawyer in the Library program sponsored by a legal aid organization, court, or other governmental or non-profit pro bono program.

#### **How Do I Find More Clients?**

How Can I Get Client Referrals?

The state bar's Lawyer Referral Service (LRS) refers clients in need of legal services to qualified attorneys statewide. Last year, the service screened more than 41,000 calls from clients seeking paid legal assistance and made approximately 13,000 referrals for those clients to participating attorneys.

Here's how it works: potential clients may obtain a referral by calling the LRS toll-free number, 800-789-LRIS (5747), and talking to one of our dedicated staff. We save you time by screening the callers to elicit pertinent information about the nature of their legal problem. Clients can also request a referral through the LRS online marketplace, where they can self-identify their legal issue and request a referral without needing to call.

Once the legal issue is identified, attorneys receive referrals on a rotational basis based on the practice area for which the referral is sought, as well as the geographical location of the attorney and client. The client receives the attorney's name, and both parties get a notification about the referral. The referred attorney may contact the client directly with the client's consent (which we obtain for you during the referral process).

Lawyers who are members of LRS pay a \$50 annual fee and, if retained by the client, remit 20 percent of all net fees earned and collected beyond the initial consultation fee. How Do I Become a Certified Specialist?

It's not uncommon for potential clients to find attorneys by reviewing the state bar's list of certified specialists or by looking specifically for attorneys who belong to a certifying organization. In Nevada, an attorney may communicate up to three specialty areas of practice, provided the certifying organization is approved and certain conditions precedent are met.

The list of approved specializations currently includes:

- Business Bankruptcy
- Child Welfare

The State Bar of Nevada has an Ethics Hotline set up to answer ethics-related questions from our membership. Call 702-382-2200 or toll free 800-254-2797 to speak to an attorney in the state bar's Office of Bar Counsel. Attorneys staff the line daily during business hours, providing direction regarding the Rules of Professional Conduct and Supreme Court Rules.

The Standing Committee on Ethics and Professional Responsibility also makes available advisory opinions on the ethical considerations of the practice of law. Being a lawyer is one of the most stressful professions in the U.S. – and there's no shame in seeking support when it gets overwhelming.

The State Bar of Nevada is committed to supporting the health and well-being of its attorneys. Programs and services range from talking to a fellow lawyer experiencing the same issues as you, to seeking clinical assistance for issues related to addiction or mental health. Most services are available statewide and provided confidentially at no cost. **Lawyers Concerned for Lawyers:** Confidential peer support for Nevada attorneys in need of support to get in – or stay – in recovery. Weekly closed-door meetings are held statewide.

**Nevada Lawyer Assistance Program:** Clinical services for attorneys suffering from abuse, addiction and/or mental health issues which may impair professional competence.

**Therapy Benefit:** If an attorney wants assistance in dealing with a difficult life situation, such as divorce, depression, stress, the death of a loved one, a traumatic case, or any other stressful incident/situation, they can request the name of a therapist by calling 1-866-828-0022. The first three sessions are provided at no charge. The inquiry and subsequent three sessions are completely confidential.

**Weekly Virtual Meetings for Stress & Anxiety:** 

Looking to speak with another attorney going through the same issues as you? At this closed-door meeting, attorneys discuss stressors in their practice, personal life, or whatever may be worth discussing with others for insights and/or suggestions on how to maneuver through difficult times.
