### The Las Vegas Chapter of the National Bar Association 2023 Soul Train Scholarship & Awards Gala

The 2023 Las Vegas Chapter of the **National Bar Association (LVNBA)** scholarship and awards gala featured bell bottoms, platform shoes, and natural hairstyles in celebration of the "Soul Train" era. "Soul Train" was a trailblazing program that showcased high energy soul, rhythmand-blues, and funk dance music in the U.S. from 1971-2006. It was the first show of its kind that prominently featured the Black community and culture. Through music, dance, and fashion, "Soul Train" showed the world the strength, beauty, power, and creativity of Black people. On September 30. 2023. the LVNBA celebrated "Soul Train's" spirit of love, peace, soul, and Black culture during its gala.

The LVNBA is an organization of predominantly Black attorneys, judges, professors, and other legal professionals. The LVNBA was originally incorporated in 1981 by a small, yet mighty, group of 14 attorneys and judges looking to uplift and advance each other and the community. Each year since its inception, the LVNBA strives to host an annual gala to award scholarships to law students and recognize individuals and organizations in the legal community who support the LVNBA's mission.

Central to that mission is promoting social dialogue with members of the bar; advancing diversity in the legal arena; cultivating leadership and professional development; and improving the science of jurisprudence through education, commentary, and scholarly analysis. The LVNBA is also committed to promoting professionalism, education, the pursuit of equal opportunity, justice for all, and much more.

At this year's gala, the LVNBA was fortunate to have Justice Patricia Lee, the first Black woman and the first Asian American to serve as a Nevada Supreme Court Justice, as its keynote speaker, and Dominique Calhoun, the 81st president of the National Bar Association, as its featured speaker, to help celebrate 42 years of service and commitment to the community.



With the hard work of the LVNBA Gala Committee, consisting of LVNBA President Angela Cook, Scholarship & Awards Committee Chair Jonathan Lee, Gala Committee Co-Chairs Mary Bacon and Jazmine Thompson, and Fundraising & Corporate Sponsorship Committee Chair Caleb Green, and all the generous community partners, members, and volunteers, the LVNBA met and exceeded its fundraising goals by awarding \$48,000 to our scholarship recipients.
