"In 2024, I was fortunate to be a presenter at the Southern Nevada Senior Law Program (SLP) Health Care Power of Attorney/Basic Estate Planning Workshop.

"Having recently dealt with the death of a loved one who suffered from a terminal illness, I can honestly say that proper estate planning is of immeasurable value to surviving family members. The emotional and mental assurance these tools offer is something that you, as a volunteer attorney, can provide when leading one of the SLP workshops.

"A special advantage, particularly for my fellow government attorneys, is that the workshops are virtually conflict-free. There is little to no legal advice being provided. Each session is always prefaced with a reminder that there is no attorney-client relationship in such a group setting.

"The benefits of the SLP workshops are twofold. They provide an array of free legal services to one of Clark County's most vulnerable and often neglected citizen groups. However, they are also structured so that attorneys of all backgrounds can gain volunteer (read: CLE) hours and experience. I sincerely hope that you will sign up to lead a workshop.
