WASHOE COUNTY

24-0140994 Criminal Record Sealing: Client would like to seal his criminal record from Washoe County. In 2010, the client was arrested and charged with a felony for trafficking. He was sentenced to 4 years of probation, which ended a year early due to good behavior. Client has ordered his CHR.

24-0143446 Criminal Record Sealing: Client would like to seal her criminal record from Washoe County. In 2021, the client was arrested and charged with a gross misdemeanor. Client was sentenced to a year on probation, which she completed in July 2022. Client would like to seal her record to obtain better-paying employment. Client has received her CHR.

24-0139906 Criminal Record Sealing: Client would like to seal her criminal record in Washoe County. In 2022 client was arrested and charged with a misdemeanor for possession of a controlled substance. Client was ordered to complete counseling, which she did. Client would like to seal her record to find employment in the medical field, as she is a CNA.

24-0138903 Last Will & Testament: Client would like to revise his current Will. Client does not own any property, and his only income is from Social Security. Client would like to donate his only belongings to Catholic Charities. Client does not have any relatives or close friends that he can name as Executor.

24-0146509 Divorce w/Minor Children: Clients seeks representation in a divorce matter with two children ages, 5 and 2. The parties have been married for five years. Client has been a stay-at-home mom throughout the entire marriage. The other party has abused her both physically and mentally. Client once left the state with the children due to domestic violence, but the other party found her and demanded her return. The other party is part of a motorcycle gang. Client has filed numerous TPOs but returns because she has no income. Recently, the other party broke her phone and laptop which contained evidence of the physical abuse. Client would like joint legal and physical custody, as well as child support and alimony.

24-0145258 Minor Guardianship: Client is seeking representation in terminating Guardianship over her two-year-old son. The child's maternal grandmother was granted temporary Guardianship, but the client was never served. The Guardianship was granted based on lies. There is a hearing set for October 17, in Dept 14.

LYON COUNTY

24-0145987 Bankruptcy Ch. 7: Client is a retired Veteran who would like to file for Bankruptcy. Clients' income is \$1440 a month from Social Security Retirement. Client has medical debt estimated at \$80K, that he is unable to pay. Client's only asset is his home. Client is at 90% of the poverty guidelines and would like to seek a filing fee waiver.

ELKO COUNTY

24-0143268 Bankruptcy Ch. 7: Client would like assistance filing for Bankruptcy. Client is currently unemployed and living with his girlfriend's family. Client has medical debt estimated at \$30K.
