## VOLUNTEER ATTORNEYS FOR RURAL NEVADANS (VARN) UPDATE FOR ACCESS TO JUSTICE MEETING MARCH 22, 2024

VARN served approximately two thousand two hundred seventy-two (2,272) persons in the calendar year 2023. Most of these persons reside in the Rural Counties of Nevada. The breakdown by counties is attached to this update, as Exhibit "1". VARN provided direct services to eighty-six (86) victims and survivors of domestic violence through its Domestic Violence Victims Assistance Program (DVVAP). The services provided were crisis counseling, emergency legal services for Protection Orders, and family law services. VARN also assisted the victims and survivors of domestic violence in receiving services, such as, payments for medical payments and counseling services which were paid by the Victims of Crime Act (VOCA). DVVAP program receives most of its referrals from the domestic violence agencies in the Rural Counties of Nevada.

VARN provided direct services to one hundred and forty- seven (147) Seniors who resided in Carson City, Douglas County, Churchill County, Lyon County, Elko County, and Storey County through its Rural Senior Legal Program (RSLP). These direct services included housing assistance, consumer problems, abuse and neglect, healthcare, and defense of guardianship.

VARN organized five (5) pro bono Lawyer in the Lobby events each month during 2023. Two (2) of these monthly events focused on Family Law questions. One (1) of these monthly sessions focused on General Law questions. One (1) of these monthly sessions focused on questions from Senior Citizens. And one (1) of these monthly sessions was devoted to questions from Spanish Speakers. Approximately six hundred and nine (609) residents of the Nevada Rural Counties participated in these Lawyer in the Lobby sessions during 2023. The Lawyer in the Lobby program served residents of Carson City, Churchill County, Douglas County, Elko County,

Esmeralda County, Eureka County, Humboldt County, Lincoln County, Lyon County, Mineral County, Nye County, Pershing County, Storey County, and White Pine County. VARN also participated in two (2) Legal Aid Fairs in Carson City in collaboration with Nevada Legal Services (NLS) during 2023.
